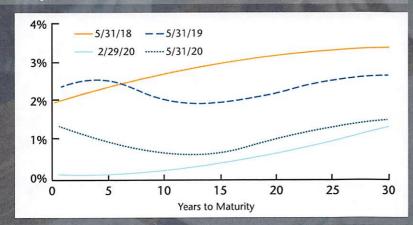

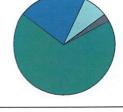
Quarterly Position Report May 31, 2020



The closing of businesses and schools along with the government-mandated stay-at-home orders due to the COVID-19 pandemic effectively brought the U.S. economy to a halt as unemployment soared. The equity markets were down as much as 35% from the record highs in February. The FOMC cut the target rate to zero lower bound in two non-meeting moves. Liquidity in the fixed income credit markets evaporated as investors hoarded cash and moved to the safety of U.S. government assets. In April, the impact of the Fed's liquidity facilities took effect and liquidity improved. Equity prices and credit spreads rallied in April and May, but remained well off the highs of February. Expectations are for a historical decline in economic growth in the first half of 2020 as first quarter GDP fell by 5%. 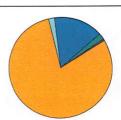

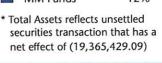

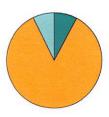
