| BACKGROUND: The Knox company is the sole source provider for the Knox Box products to provide immediate access to building keys for fire and law enforcement to access a campus during an emergency situation. The Brownsville Fire Department already has an existing partnership with the Knox Company that provides them with a master key to open any Knox box in the city during an emergency when keys are not available. The Knox Company will provide a secondary key that will work independently for BISD Police Department to have the same access to these emergency keys. The cost per unit will be \$998.79 and total one-time cost for all campuses will be \$53,934.65. | | | | | | | |
