



### NORTHWEST REGIONAL ESD BOARD MEMBER FOR ZONE 5


**SITUATION**

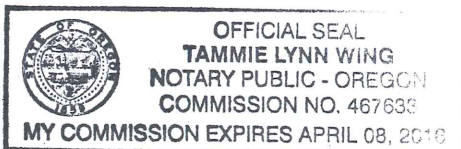


**DECLARATION**
