Thank you for helping your student to become a responsible library patron.

EACH LORNA BYRNE STUDENT IS ALLOWED TO HAVE 3 BOOKS CHECKED OUT FOR 3 WEEKS. IF THE BOOKS ARE RETURNED ON TIME OR RENEWED BEFORE THE DUE DATE, NO FINES ACCRUE. IF THE BOOKS ARE NOT RETURNED OR RENEWED BEFORE THE DUE DATE THEN A .05¢ FINE IS CHARGED FOR EACH BOOK, EACH DAY UNTIL IT IS RETURNED OR RENEWED. IN THE CASE THAT BOOKS ARE LOST OR DAMAGED BEYOND REPAIR, THE STUDENT WILL BE REQUIRED TO PAY THE REPLACEMENT PRICE. WHEN FINES REACH AN EXCESSIVE AMOUNT AND/OR THERE IS A HISTORY OF LOST/DAMAGED BOOKS, STUDENTS MAY LOSE THEIR LIBRARY PRIVELEDGES.

### Bullying at Lorna Byrne Middle School

Like all schools, LBMS experiences incidents of bullying.

For the past two years, we have been working hard to establish a response which both protects the rights of victims and perpetrators of bullying.

This year, we are implementing a three-pronged approach:

- 1. We are educating all students school-wide about what bullying looks and sounds like,
- 2. We are working with a group of students to prevent bullying, harassment and violence, and
- 3. We are encouraging students to report bullying, and support them when they do so.

What has been most interesting is that many bullying incidents go unreported for a number of reasons.

Many parents come in to report that their student has been bullied "the entire school year" and that the school "has done nothing about it". Parents are often surprised to learn that their student has not reported.

To support the prevention of bullying, harassment and violence at LBMS, we ask parents to:

- 1. Talk to students every day about what went on at school. Listen carefully, and if necessary, press for information – your student may resist, but he or she wants your help.
- 2. If your student reports an incident, ask them to report it to the office, and make sure he or she follows through.
- 3. Finally, call the school! If your student won't report, you can.

Remember: for your school to help, we have to know about it! Let's have a great school year working together!

#### **ADVERSE WEATHER CONDITIONS**



Straight Line Bus Routes: In the event of adverse weather conditions parents are advised to tune in to Radio Stations KRWQ, KAJO, KLDR, KBOY and TV Stations KOBI (5), KDRV (12), KTVL (10) or Three Rivers School District Web Page for information on school bus schedules.

Sometimes weather conditions leave roads blocked or unsafe to travel but school is still being held. Under these circumstances "straight line routes" will be run. This is the information you will get on the web page or radio/TV stations.

Listed below are the straight line routes run. If you live on one of the roads the buses cannot travel, you may bring your student to the nearest intersection of the main road traveled. This will also be the stop for the afternoon drop off.

# "Lights On" LBMS Extended School Day Program Monday – Friday 7:25 am – 8:10 am Monday – Thursday 3:15 pm – 5:15 pm

Dear Parents & Guardians,

LBMS, through our 21<sup>st</sup> Century Grant, offers many opportunities and experiences in our extended day program called "Lights On". We provide a safe place for your child to participate in after school activities. "Lights On" activities begin Monday, September 26, 2011, and will end May 31, 2012. A nutritious snack is served before activities begin each evening.

Our main year-long activity is Homework Help House (HHH). On Monday, Tuesday, Wednesday and Thursdays, our after school program provides your child with staff assistance on homework, as well as skill development in specific academic areas. HHH also provides a quiet atmosphere to read, write and complete unfinished class work. Teachers and parents/guardians may recommend students to stay for HHH. **Students with failing grades, if they choose to stay after school, are required to attend HHH.** 

HHH is also offered in the morning from 7:25 am – 8:10 am, Monday thru Friday. Students must either walk to school or be dropped off by parents no earlier than 7:25 am. There is NO ACTIVITY BUS available to your child for the afternoon sessions so it is crucial that you pick your student up promptly at 5:15 pm. Parents/guardians of students not picked up by 5:15 pm will receive a phone call from our staff. If you have any special instructions for your student regarding pick up, please have student bring a note to the school office.

**Students are expected to follow PBIS guidelines.** They are required to sign up for a specific activity and remain in that activity until 5:15 p.m. **Non-compliance with "Lights On" rules may result in the loss of after school activity privileges.** 

The schedule for "Lights On" is on the bulletin board in the cafeteria and throughout the building. Other activities that will be offered throughout the year are:

ART EXTRAVAGANZA, BAKING, SCRAPBOOKING, SEWING, SMILE, SNAK, and VENTRILOQUISM with many more to come!

Participation in after school activities requires students to have a LIGHTS ON permission slip on file.
