Judy Barbo made a motion to approve the payment of \$43,807.80 to Balfour Beatty Construction, LLC as the final acceptance and payment for the 2012 Phase Six Bond Projects. Tracy Fisher seconded the motion. The motion carried 7-0.

Amy Dungan made a motion that the Board add, revise, or delete (LOCAL) policies as recommended by TASB Policy Service and according to the Instruction Sheet for TASB Localized Policy Manual 96. Thom Hulme seconded the motion. The motion carried 7-0.

Susie Kemp made a motion to adopt the Resolution regarding Vouchers, Taxpayer Savings Grants, Tax Credits, and Other Mechanisms that Reduce Public Education Funding. Tracy Fisher seconded the motion. The motion carried 7-0.

Amy Dungan made a motion to accept resignations for CISD professional personnel as recommended by the Superintendent. Tracy Fisher seconded the motion. The motion carried 7-0.

Amy Dungan made a motion to accept new hires for CISD professional personnel as recommended by the Superintendent. Judy Barbo seconded the motion. The motion carried 7-0.

David Apple made a motion to adjourn the meeting. Judy Barbo seconded the motion. The motion carried 7-0.
