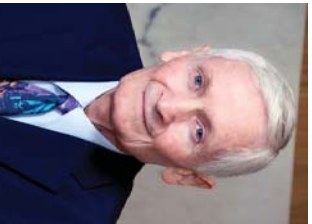

A Lifetime of Learning
Jim Jones received his license to practice law in Idaho in 1967. During the last 50 years, he has spent half of that time in private law practice and the other half in public service: the Army, as State Attorney General, and on the Idaho Supreme Court. During this keynote, he will tell how he was inspired to public service, how it has been a valuable and continuing learning experience, and why it's important for today's students to be knowledgeable about and engage in public affairs.

District Preparation, Procedure, & Strategies for Successful Labor Negotiations

A review of applicable Idaho laws relating to the negotiation process with local education associations as well as the practical considerations necessary to reach fair and equitable agreements within the District's budgetary constraints.
