Issue Summary:

During the December 2024 board meeting, the Board approved migrating the District's video surveillance system to Genetec through Convergent Technologies. This migration has started, with TechOp's assistance. It has been determined that a new server needs to be installed in order to complete the migration. This new video management system will allow the District to use multiple brands of cameras, will link all buildings (including the new facilities building) into one system, and is easier to use for reviewing footage, thus allowing us to respond to security and safety issues in a more efficient manner.
