1. Call to Order:

Chris Flor, Board President, called the special meeting of the Belton Independent School District Board of Trustees to order at 5:30 p.m. He stated that a quorum of Board Members was present, noted Rucker Preston was absent, that the meeting had been duly called, and notice of the meeting had been posted in accordance with the Texas Open Meetings Act, Texas Government Code Chapter 551.

3. Closed Session (Texas Government Code, Subchapters D and E)

A. Consultation with Attorney, Section 551.071

At 5:30 p.m., Mr. Flor announced that the Board would go into closed session for the purposes of consulting with its attorney, as allowed by Texas Government Code §551.071.

At 5:40 p.m. the Board reconvened in open session. Mr. Flor indicated the Board did not take any vote or other action in closed meeting.

4. Level III FNG parent/student grievance

Mr. Flor informed the room that a Level III grievance filed pursuant to Belton ISD Board Policy FNG(LOCAL), which is for parent and student complaints. Typically, there are live presentations made before the board deliberates a grievance; however, due to summer scheduling conflicts, the grievants and administration have agreed to submit this case for review based on written submissions. The evening's proceedings will be conducted differently than has been in the past because of this.

Pursuant to the complainant request, the board will conduct its deliberation of the grievance in open meeting, but the board may consult with its attorney in closed meeting in accordance with the Texas Open Meetings Act.

The Board reviewed the written submissions.
