## 2025-2026 SUPERINTENDENT PRIORITIES/GOALS

• Seek Supplemental Revenue Sources to Support District Operations and Programs for the 25-26 School Year

Administration is looking at a new and updated streaming service that has the potential to generate revenue for the District activities program through advertisements. Our volleyball and basketball teams are currently using Hudl for the recording, playback, stats collection, and highlight reels for players. For an additional nominal fee (around \$1,500), the District can purchase and install camera equipment to stream activities and events without the need for camera operators. Quite a number of districts in Alaska have moved to this service, with lots of positive feedback. The District plans to work with local business for event sponsorships opportunities (similar to what we do now), but incorporate digital advertising options to be hosted online during events.

• Support School Board in Process for Selecting New Superintendent [2026-2027 School Year]

AASB has posted the job vacancy announcement with the following: <u>AASB online application portal Revelus</u>; <u>AASB website</u>; and 10 other state associations across the nation that utilize Revelus. AASB has communicated that the vacancy has also been posted with the Alaska Education Retention and Recruitment Center (formerly Alaska Teacher Placement), Alaska Council of School Administrators, the Alaska Superintendents Association, and the National Association of Superintendent Searchers connections hub. However, I have been unable to find the postings on these websites and have asked AASB for specific web addresses (URLs) showing the postings and am awaiting a response. I will share those with the Board once received.

## **POLICY REVIEW**

- The Policy Committee met on September 16, 2025 to review the newly proposed Chapter 10000 Charter Schools. Recent legislation requires districts to have certain policies around charter schools, whether or not charter schools are in place in communities. Committee Members thoroughly reviewed the model policies on charter schools established by AASB. A recommendation under the New/Unfinished Business of the October 8, 2025 meeting agenda proposes the motion to adopt the related policies as an entire chapter (First Read). A recommendation for the November meeting will be to adopt and put into effect the chapter on Second Read.

# **OTHER**

October Count

The Alaska Department of Education and Early Development (DEED) October Count is the annual official student enrollment count for public schools. The student membership data, collected during a 20-day period near the end of September through October each year, is the basis for determining school funding and producing official stats for yearly District reports.

This year's October Count period began September 29 and ends October 24, 2025. Enrollment (not attendance) comparison includes:


#### • Federal Government Shutdown

Of the federal funds that the District receives, we anticipate no impact to FY26 related to Title funds, as that revenue is forwarded budgeted at the federal level and the Impact Aid for this year is already in process. FY27 Impact Aid funds, however, may be impacted depending on the length and degree of the shutdown. Generally, the District anticipates approximately \$40,000 in revenue from this program yearly. Impact Aid is federal funding for public schools in districts that have a loss of local tax revenue or increased costs due to the presence of federal property or children living on federal lands, such as military bases, tribal land, or low-rent housing.

# • DEED Fall Staff Accounting Report

The information in this data collection is used for the Every Student Succeeds Act (ESSA) report, Consolidated State Performance Report (CSPR) to the U.S. Department of Education, Alaska's Public School Report Card to the Public, the federal Common Core of Data (CCD), the federal Special Education Personnel report, legislature reports (SB241 and SB133), cross-checks with teacher certification, and other special requests from other state agencies. Staff have worked diligently to submit the report prior to its deadline.

• The Safety-Facility Committee recently met and reviewed the required trainings that staff complete yearly. As part of this training program, our insurance pool (Alaska Public Risk Alliance—APRA) provides premium rebates to its members in the following ways: Property Insurance (3%); Liability Insurance (8%); and Workers' Compensation Insurance (8%). To date, 50 percent of the staff have completed 100 percent of the training modules; 24 percent of the staff have completed 80-99 percent of the training modules; and thirteen percent of the staff have completed 50-79 percent and 25-49 precent of the training modules, respectively. Completing additional tasks like building and fire system inspections, quarterly safety meetings, and human resources practices this year will earn the District nearly \$22,000 in rebate revenue from its \$114,000 annual premium fees.
