SUBJECT: IMRF Employer Audit

DATE: May 22, 2012

Commencing with March 12, 2012, representatives from IMRF (Illinois Municipal Retirement Fund) conducted what is called an "Employer Audit" and provided their findings in a letter dated April 19, 2012. There were six exceptions, and, for the most part extremely minor, but IMRF requires a formal letter delineating corrective actions. One exception, however, requires a resolution to be adopted by the Board of Education.

In order to continue to have IRS Code Section 125 deductions treated as IMRF wages, it will be necessary to pass Resolution 6.72 (***suggested resolution to include compensation paid under an IRS Code 125 plan as IMRF earnings***) with an effective date of when the District started reporting this way. This has been a practice going back prior to 2002; however, there is no record of the Board adopting this resolution. So, the attached resolution identifies July 1, 2002 as the effective date.

This will return to the Board for formal approval at the June 12, 2012 meeting and forwarded on to IMRF and all corrective actions required will have been completed.
