1 st Open Forum	Willie Hudspeth-President of NAACP for Denton county addressed the Board regarding naming a school after an African American specifically Catherine Bell Elementary. Mr. Hudspeth asked who is responsible for choosing the Braswell High School head football coach and feels the district does not have an African American representative in this position.
Discussion of Braswell High School Utility Update	Paul Andress, Executive Director of Operations introduced Tom Rutledge with Teague, Nall & Perkins. Mr. Rutledge provided the trustees with an update related to sewage utilities at Braswell High School, the municipal partnerships, and the collaboration of governmental entities.
	Mr. Rutledge shared information regarding the Mustang Supplemental Utility District and the capacity to serve the new school including the possibility of installing a lift station. The station would then be maintained by Mustang SUD through an inter-local agreement. The alternative option would be to go through the Freshwater Supply District 11A for service.

Discussion of Adult Education and Literacy Program Update	David Gerabagi, Director of Adult Education & Literacy Program presented the Board about new initiatives regarding Adult Education and Literacy Programs at Denton ISD. Workforce Integration Opportunity Act (WIOA) was signed into law by President Obama shortly after he took office. Adult Education oversight was transferred from TEA to Texas Workforce Commission. WIOA serves low-income, low literacy and low skilled adults. The scope of adult education is to include transition to postsecondary education and employment. Denton ISD serves Denton County and Collin County workforce. GED's awarded in Texas per 1000 adults is less than the national average. Texas leads many states in the percentage of adults without a high school diploma.

Discussion of Annual Bilingual/ESL Report	Teresa Taylor, Director of Bilingual/ESL Program provided an overview of the Bilingual/ESL programs. Since the inception of the program in 1999 the District had 1162 students in the Bilingual/ESL program and currently has over 4113 students, a 250 student increase over last year.
	Currently, the district employs 117 educators who deliver bilingual instruction. The district offers a one-way language enrichment and ESL models at eight elementary schools and the district's two schools for young children. Twelve elementary schools offer the traditional ESL program, and two elementary schools have two-way dual language enrichment programs.
	Ms. Luna-Taylor highlighted the staff development the district provided teachers this summer, including the presentation by Dr. Samuel Betances. Staff development is also offered through a partnership, in its fourth year, with Lewisville ISD, the University of North Texas and Region 10 ESC to provide secondary math/science teachers with professional development that enhances their knowledge/skills for the purpose of improving the academic and linguistic achievement of English Learners.
	The grant of \$985,700 was funded by the Office of English Language Acquisition of the U. S. Department of Education.
