A Special meeting of the Board of Trustees of Southwest ISD was held Tuesday, August 5, 2026, beginning at 6:00 PM in the Central Office Building No. 400, 11914 Dragon Lane, San Antonio, TX.

I. Call meeting to order/Roll call

The meeting was called to order at 6:00 p.m. by Board President Vasquez.
