SUBJECT: Vehicle Bid

DATE: June 23, 2015

Currently, we have two vehicles (a 1993 Ford F-250 pick-up truck and a 1999 Dodge Ram Truck) that have exhausted their useful lives and are down more often than available for use). Rather than investing any financial resources into their repairs, we are recommending replacement of these two vehicles with a Ford Transit Van, which will be a relegated vehicle for our in-house painter. This vehicle, like all our other Maintenance vehicles, will serve a dual purpose – outfitted for our painter (who works a 2:00 p.m. -10:30 p.m. shift) as well as in winter, being strong enough to attach our large salt spreader for districtwide use.

The Director of Buildings & Grounds prepared the appropriate bid specifications for a 2016 Ford Transit Van and further prepared the appropriate legal notice (see attachment #1) announcing such bid. The legal notice appeared in the May 13, 2015 issue of the Wednesday Journal and such notice called for bids being received at 1:00 p.m. on Wednesday, May 27, 2015.

Attached is a list of bidders invited to bid as well as any other vendors responding as a result of the bid notice (see attachment #2). On Wednesday, May 27, 2015, four bids were received and all firms offered a trade-in value associated with the existing 1993 Ford F-250 pick-up and the 1999 Dodge Ram trucks. The four net bids (after trade-in) were 29,960, 30,998, \$31,125, and \$31,187 (see bid summary – attachment #).

We are recommending award to Rizza Ford in North Riverside, IL. This recommendation will return to the Board for approval at its July 7, 2015 meeting and will be paid from the forthcoming 2015-16 Operations & Maintenance Budget.
