Mid Valley responded to one Freedom of Information request.

On July 21, 2016, Ms. Patti Lopuszanski requested the following:

1. Per (105 ILCS 5/10-17) (from Ch. 122, par. 10-17) Sec. 10-17. Statement of affairs. All school districts are to publish their Annual Statement of Affairs and submit to the ISBE along with a list of all contracts over \$25,000. Mid-Valley Special Education Cooperative RCDT: 31-045-3030-61 does not have an Annual Statement of Affairs posted on the ISBE website for the Fiscal Year Ending June 30, 2014 per Megan Griffin of the ISBE. I respectfully request a copy of the full Annual Statement of Affairs for FY Year Ending June 30, 2014 that was not filed and posted on the ISBE website along with the list of contracts and/or payments over \$25,000 paid out by Mid-Valley Special Education Cooperative. A copy of the required published newspaper notice, date it was published and copies of any form of communication between any employee of the ISBE, Mid-Valley Special Education Cooperative and the St. Charles School District CUSD 303 related to the Annual Statement of Affairs for the Fiscal Year Ending June 30, 2014 related to RCDT: 31-045-3030-61 Mid-Valley Special Education Cooperative.

Response: A copy of Mid Valley Special Education Cooperative's Annual Statement of Affairs for the Fiscal Year Ending June 30, 2014, a copy of the published newspaper notice, and a copy of the email from ISBE confirming receipt of Annual Statement of Affairs on 11/20/2014 were provided.

2. "After December 15 annually, upon 10 days prior written notice to the school district, the State Board of Education may discontinue the processing of payments to the State Comptroller's office on behalf of any school district that is not in compliance with the requirements imposed by this Section. The State Board of Education shall resume the processing of payments to the State Comptroller's Office on behalf of the school district once the district is in compliance with the requirements imposed by this Section. Per (105 ILCS 5/10-17) (from Ch. 122, par. 10-17) Sec. 10-17. Statement of affairs." Based on this information from Illinois General Assembly Compiled Statutes on what date did Mid-Valley Special Education Cooperative file the Annual Statement of Affairs for the Fiscal Year Ending June 30, 2014 and how much funding was lost/put on hold for not filing the Annual Statement of Affairs for the Fiscal Year Ending June 30, 2014 due to non-compliance?

Response: Filed ASA on 11/20/2014 so no funding was lost.
