### OVERVIEW OF SUPPORT FOR PREKINDERGARTEN-KINDERGARTEN TRANSITION WITH EARLY LEARNING SCHOLARSHIP DOLLARS

- Grant funds were earmarked for families we currently serve in district early childhood programs and were funded by scholarships awarded to Head Start and School Readiness through our applications from parents in those programs.
- Because we were able to carry funds forward, the 2<sup>nd</sup> year, we broadened the support to all elementary schools.
- Grant funds supported Round-Up activities with the use of best practices including:
  - o creating a family friendly environment
  - o utilizing evening round-up options
  - o paying for buses to orient children to riding
  - o buying WELCOME TO KINDERGARTEN ROUND-UP banners
  - avoiding testing/assessments (children in district ECH programs are assessed 3 x a year)
  - providing food or refreshments for Round-Up and Kindergarten
    Connection participants
  - building loyalty and community with ISD 709 logo water bottles and school logo cinch sacks
  - o collaborating with PTSA
  - o bringing back the Kindergarten Connection program
  - beginning a conversation with PreK and Kindergarten Transition
    Forum
  - o offering paid time for school staff to attend programming outside their school day

#### **Duluth Public Schools Early Childhood Funding Opportunities for 2015-16**

- Early Learning Scholarships \$104,268. This money funds 8 part-time paras in Head Start. Our portion of 35 scholarships. The rest of the money \$69,276 goes to School Readiness for program expansion from 3 to 4 days and adding 3 PT paras Also helped lengthen CE PreK time to 3 hour sessions.
- Early Learning Scholarships \$86,772. For piloting transportation at 2 collaborative sites. This is extra money we applied for and received due to the legislature raising the cap on scholarships from \$5000. To \$7500.
- Family Service Collaboration of Southern St. Louis County/FSCSSLC \$19,688.To be used for mental health consultation for School Readiness/ECFE/Head Start and Community Education Preschool. We have contracts with 2 new mental health consultants, Mary Ann Marchel and Krista Harju. The remaining funds will be used to pay facilitators to run a Circle of Security group for professionals over the course of the 2015-2016 school year. 22 staff are signed up for this opportunity. They will receive a stipend for their attendance.
- The Northland Foundation \$5000. This will fund 2 more sessions of Race Awareness Workshops for all Head Start staff and will allow us to pilot a Dad's Group led by one of our staff.
- The Northland Foundation \$4000. This will support building a system of alignment between Prekindergarten and Kindergarten. Includes looking at assessments, curriculum and standards, observation of each other's classrooms and more opportunities like the PreK-K Transition Forum held last year.
- The Northland Foundation also provided the opportunity for a team of ISD 709 staff to be trained along with others in the state on the Framework for Planning, Implementing, and Evaluating PreK-Grade 3 Approaches authored by Kristie Kauerz, Ed.D. from the University of Washington.
- **PreK-3 Leadership Series** sponsored by MDE Assistant Superintendent Amy Starzecki has pulled together a team at the district level to participate in this opportunity.
- 2015 Omnibus Education Finance Bill appropriated increases in state aid entitlement for School Readiness for the biennium. This will allow for program enhancement and expansion. ECFE per pupil formula increase (2% each year) funding formula is now tied to the K12 formula.
