13. Business

- **A.** Extra Duty Stipends I have summarized my recommendation from last month into a one page document.
- **B.** School Calendar Proposal 2019-1010 / 2020-2021 The Calendar Committee has met and is recommending the Board approve Calendar Option B Calendars for both the 2019-20 and 2020-21 school years. This option has the first semester at our high schools ending before Christmas Break and students getting out of school before Memorial Day both years. I am recommending the Board approve as presented.
- C. School Calendar Changes State Playoffs I have been approached by administrators with concerns over having enough substitutes at Minico for February 15, due to State and District playoffs and other events scheduled that weekend. Due to the hard feelings that developed when we did take time off last year for one sport but not another, and the fact that we are just barely meeting our seat time requirements for our seniors in both high schools, I am recommending that we NOT cancel school to allow for attendance at State Playoff games this year. We could look into adjusting future calendars to allow for such contingencies in the future.
- **D.** Senior Celebration Request Mt. Harrison is requesting \$1,000 for their senior dinner currently scheduled for May 17. I would recommend the Board seriously consider approving this request and if at all possible attend their dinner as it was a huge success last year!

NOTE: Minico has informed us that their senior celebration committee is not asking for any funds from the District this year.

E. Health Occupation Students of America (HOSA) Request – The Minico HOSA Club is asking for Board approval for a fundraiser dinner and silent auction to help defray the cost of participating in the State competition in April.

F. New/Amended/Deleted Policies -

- Policy D232.00 Use of Animals in Educational Programs (F1, F2) The changes discussed at the last Board meeting have been made to the Student Permission Form for this policy. I am recommending it be held over for a third reading.
- 2. Policy D238.00 Homebound Students This is a new policy from the Idaho School Board Association (ISBA) that we have edited. I am recommending that it be held over for a second reading.
- **3.** Policy D280.00 Graduation Requirements We have removed the Salutatorian & Valedictorian Selection from this policy and moved those selection guidelines into their own policy (284.00). This is a first reading but since there are no changes to the policy itself I am recommending it be approved as presented.
- 4. Policy D284.00 Salutatorian & Valedictorian Selection We have taken this out of Policy 280.00 and created a new policy. We have added clarifying language so that the policy applies to both high schools. Since there are no changes to the selection guidelines themselves, I am recommending it be approved as presented.
- 5. Policy D372.50 Suicide Prevention We have received notice from the State Department of Education that they have a model Suicide Prevention Policy. I will have the Policy Review Committee (PRC) compare that policy with this one (which includes updates from ISBA). I am recommending this be held over for a third reading.

- 6. Policy D570.00 Employee Recognition We deleted a reference to the Idaho Youth Ranch (IYR) in the policy. Since this was the only change made I am recommending approval without a second reading.
- 7. Policy D372.00 Retirement Recognition We began looking at this policy because it indicated the bonus would be paid in May and the wording needs to change to be paid in the employee's final pay check. I am also recommending that the Board increase the bonuses from \$200, \$400, \$600 to \$250, \$500, and \$750 respectively for all staff and \$100, \$200, \$300 to \$150, \$300 and \$500 for part-time bus drivers. It has been a long time since these amounts were adjusted and I am recommending approval with only a first reading and that these be put in place for this year.
- 8. Policy D740.00 Federal Cash Management System This is a second reading and I am recommending approval if there are no comments or corrections.
- **9.** Policy D740.10 Grant Financial Management System This is a second reading and I am recommending approval if there are no comments or corrections.
- **10.** Policy D740.20 Fiscal Accountability and IDEA Part B This is a second reading and I am recommending approval if there are no comments or corrections.
- **11.** Policy D740.30 Retention of Records Relating to Federal Grants This is a second reading and I am recommending approval if there are no comments or corrections.
- **12.** Policy D742.00 Allowable Use of Grants This is a second reading and I am recommending approval if there are no comments or corrections.
- **13.** Policy D750.00 District Purchasing This is a second reading and I am recommending approval if there are no comments or corrections.
- **14.** Policy D774.00 Disposing of District Property This is a second reading and I am recommending approval if there are no comments or corrections.
- **15.** Policy D802.50 Safety Busing Non-Instructional Operations This is a second reading and I am recommending approval if there are no comments or corrections.
- **16.** Policy D818.00 Certificated Bus Drivers This is a second reading and I am recommending approval if there are no comments or corrections.
- **G.** Travel Requests There are several travel requests from District Service Center and Minico.
- H. Personnel Recommendations As we prepare for Summer School it has been recommended that we establish a set salary for aides similar to the set salary for teachers.
