## **NSBSD Strategic Plan Goal:**

4.0 Financial & Operational Stewardship: Effectively employ our operational and financial resources to support our strategic goals and long-term stability of the district.

## **Issue Summary:**

The Legislative Committee met on August 29, 2022 at 3:00 PM. The committee reviewed the Association of Alaska School Boards Where We Stand document, their resolution process and timeline, Board of Directors sun-setting resolutions, and draft resolutions proposed by AASB staff. The purpose included setting the groundwork for the work session "Resolutions," setting the groundwork for the Rural Caucus during the AASB Annual Conference; and to set the legislative priorities for the legislative session.

The legislative priorities were derived from the Belief Statements to set the "Big Picture" which included: Local Governance; Educational Programs and Funding as Top Priority; Meeting School Facility Needs for Alaska Students; Funding for Early Learning Programs in Alaska; Language, Cultural, and Ethnic Diversity; Supporting Sobriety and Substance Use Prevention; Prevention/Early Intervention; Equity in Education; Alaska Native Teacher Hire & Retention; Quality Staff Improves Student Learning; and Early Childhood Education.
