Bids were received on January 15, 2015 for Bid Package T2. Bid Package T2 is the replacement of the teacher and lab computers.

### **Bid Evaluation Summary and Recommendations**

After an extensive review of all bid proposals, a thorough post-bid interview was held with two of the bidders to verify that proposals were inclusive of the scope of work, evaluate bid voluntary alternates, and gather information on related experience. The attached Bid Tabulation indicates the bids received, company name, base bid, and proposed voluntary alternates.

Based upon the evaluation of the project team, we recommend that a contract be awarded to the following company. **This bid is within the bond budget allocated for this work.**

This category replaces the existing computers throughout the district (3372) over the next two (2) years. The initial buildings teacher computers will be replaced this spring after hours. The buildings slated for this spring are Hayes, Kennedy, Roosevelt, Riley, Emerson, and Franklin. This contractor will also be removing the existing systems which will be stored within the district.

The replacement computers will be Hewlett Packard Elite Desktop 800 G1 Small Form Factor and consist of an Intel Core i7-4790 3.6G HD 4600 CPU, and include 8GB of RAM, a 256MB SATA hard drive, and an E221c Monitor with webcam and speaker bar. The base bid for the computers includes a three (3) year warranty, with the acceptance of voluntary alternate one the additional two (2) years will extend the warranty period to five (5) years total.
