Also, she was concerned about how the parents are not being notified about the threats being made to the school. She has addressed this concern with the principal and the principal stated to her that it was on Facebook. She had a problem with this because there are some parents that do not have Facebook and she was one of them. She asked the board members what could be done to communicate better with the parents that don't have Facebook. She usually finds out after she gets a text from her daughter that she is scared because they are on lock down and as a parent she is not aware of what is going on.

#### 6.0 AWARDS/RECOGNITIONS

6A RECOGNITION OF BIANCA BOSQUEZ, CROSS COUNTRY CHAMPIONSHIP STATE MEET

Katrina Alejandro recognized Bianca Bosquez, Cross Country State Qualifier. Bianca is a sophomore and she qualified for the regional championship at the 2024 Regional Cross Country Meet which earned her a spot at the State Cross Country Meet. She finished twenty-ninth at the State Cross Country Meet. Robstown ISD is extremely proud of Bianca's dedication, perseverance, and accomplishments both on the cross-country court and in the classroom. Additionally, Coach Adolfo Gonzalez

recognized his cross-country team members that qualified for regionals. Mario Cortinas and Devan Alaniz qualified for regionals. He also recognized his managers.

#### 6B PROUD YOU'RE A PICKER AWARD

Katrina Alejandro recognized Coach Katherine Pruneda as the Proud You're a Picker Award recipient. Ms. Pruneda goes above and beyond her role by demonstrating dedication to her students and colleagues. She fosters a positive and welcoming environment consistently working towards common goals with enthusiasm. She is an invaluable asset to the school district. Also, Ms. Alejandro presented several gift certificates to her from the RISD Picker Partners.

#### 6C LIFE SAVER AWARDS

Katrina Alejandro recognized Tracey Zapata for the Life Saver Award for noticing a fan in medical distress and immediately alerting the medics and police. The fan was having a heart attack and later underwent bypass surgery. She thanked Mrs. Zapata for being alert and taking quick action. Also, Ms. Alejandro recognized Candace Ramirez for demonstrating extraordinary quick thinking on October 24, 2024, when she performed the Heimlich maneuver on a student who swallowed a quarter. Also, Mrs. Zapata and Ms. Ramirez both received gift certificates from the RISD Picker Partners.

#### 7.0 MADAM PRESIDENT REMARKS

President Lori Ann Garza reminded the board members about the upcoming board workshop on December 5, 2024. She hoped to see all of the board members there.

#### 8.0 SUPERINTENDENT REPORTS

#### 8A SUPERINTENDENT UPDATE

Dr. Marc Puig reported that they continue to build momentum in fostering effective leadership and strengthening Tier I instruction through initiatives. They have been working with the National Institute for Excellence in Teaching (NIET) for a refresher and deep dive into Domain II and III of the T-Tess rubric. The Teaching and Learning Team, along with himself, participated in a TIA training at the ESC-2. This initiative aligns with the school district's goals of recruiting and retaining top-tier educators while fostering excellence across the school district. He hosted a Zoom consultation with TEA to review progress at Seale Jr. High School and Lotspeich Leadership Academy which are under the Targeted Intervention stage. He is looking at applying for a grant, which aligns with the school district's instructional pillars and will help support school improvement. He thanked the Business Office for receiving a "Superior" rating on the FIRST report. The naming of the Richard Gillespie gymnasium will take place on Friday, November 22, 2024, at 6:00 p.m. at the RECHS gym. He will be hosting a town hall meeting on Tuesday, December 3, 2024, at 7:00 p.m. at New Life at the Cross. This will provide an opportunity for the administration to dialogue with the community. The current enrollment is at 2,573, the average daily attendance is at 2,258, and the attendance rate is at 91.7%.

#### 9.0 PRESENTATION/INFORMATIONAL ITEMS

9A THANKSGIVING BREAK – NOVEMBER 25-29, 2024

Dr. Marc Puig announced that the Thanksgiving Break will be from November 25, 2024, through November 29, 2024.

9B CHRISTMAS BREAK – DECEMBER 23, 20244 – JANUARY 6, 2024 Dr. Marc Puig announced that the Christmas break will be from December 23, 2024, through January 6, 2025.

#### 9C TEACHER INCENTIVE ALLOTMENT

Rachel Medrano reported that the Teacher Incentive Allotment was a program for teachers to earn more pay while remaining in the classroom. The legislature passed this program with House Bill 3. The goal is to get teachers who are doing an amazing job close to a six-figure salary. They want to participate in this program because they want to recruit, retain, and reward educators who are bringing the school district to life. Belinda Alaniz reported that this program was still in the planning stages right now. There are two different ways that teachers can apply or be part of it. One of the ways is through the district plan and the second way would be through the National Board Certification. The second route would require a cohort of teachers to agree to it. A pre-application has been started and they have had meetings with TEA. They are in year one and in the second year, they will pull together the data. Once the data has been submitted, the next step will be the approval. The application is due on April 15, 2025. Ninety percent of the funds have to be used for teachers and or student-based employees and ten percent can be used on administrative staff. Also, information about TIA can be found on the school district's website. Joshua Garcia reported that the teachers would be rated on different teacher performance and they could make from \$7000 to \$29,000 added to their salary.

#### 9D ACADEMIC UPDATE

Adriana Tagle presented a short video from San Pedro Fine Arts Academy showcasing how the students were taking ownership of their work. The teachers and students in the classrooms that she visited at different campuses also show that they are making progress because of the visits. She shared results from English I, English II, and Algebra I with increases at the meets and meets masters. Overall, based on what they are seeing at the different campuses and the increases in English I and II and Algebra I, they are making progress.

#### 9E TECHNOLOGY UPDATE

Richard Gonzalez reported that the internet project at Robstown Early College High School has been completed. The next campus up will be the Seale Junior High School.

#### 9F M & O UPDATE

Ron Lawver reported that the high school parking lot had been completed under budget and on time. The signage for the Richard Gillespie has also been completed. The HVAC project is still ongoing with the high school, Ortiz, and Salazar being completed. The rest of the campuses are up next. They replaced lights at Seale Jr. High School and San Pedro Fine Arts Academy. A meeting has been held with the roofing company which will be the next big project coming up.

#### 9G RISD DONATION

Dr. Marc Puig reported that the following donors had donated to the school district: 1) Helping Hands Pediatric Rehabilitation Services donated \$200 to the Special Education Department, 2) Chad Sweigart donated \$200 to the Special Education Department, and 3) Edward Lee Bochard donated \$500 to the RECHS football program.

Dr. Marc Puig reminded the team and community that they have invested in a parking lot, HVAC projects, and now the school district's roofs. This project has to do with the roofs and they have found a way to repair the roofs. He has asked Robert Tijerina, the school district's financial advisor, to present an update to the last presentation that he made. Robert Tijerina reported that at a previous board meeting, he presented preliminary numbers to the Board. The school district will be able to borrow roughly \$2,870,000 to fix the school district's roofs. The school district is in a really good position because the current M&O debt will be paid off in 2030. For the years 2031-2035, the school district will be able to use the funds that they were used to pay off the old debt. They were able to get a 44.788% from Amegy Bank for a fifteen-year loan. The first ten years are locked in and the remaining years can be

readjusted. The school district will have the opportunity to pay off the debt in ten years. If this item is approved by the Board, the school district will receive the funds on December 19, 2024.
