# X. <u>Approval of Amending COVID Quarantine Protocols</u>

The motion was made by Mr. Elms proposing to consider changing students quarantine period to 5 days as well as staff or include wording to give our Administration the leeway at their recommendation, to go with TEA's policy.

The motion was amended by Mr. Elms proposing to include language that if a student has a positive covid test and a doctor's note that they are not penalized for staying home from school.

Dr. Dittfurth called the question.

The motion was amended by Mr. Elms that if our board does not feel comfortable changing the language for a student being quarantined from 10 to 5 days, I would like include language that allows our Administration, if TEA makes changes from now to the next meeting, to be proactive in coordinating our policy with what TEA says.

The motion was amended by Mr. Elms and seconded by Dr. Dittfurth giving the Administration the authority to modify the quarantine protocol period for students from 10 to 5 days if directed by TEA.

Dr. Dittfurth called the question on the motion amendment.

All members voted in favor of the motion. The motion carried.

Dr. Dittfurth called for the question.

The motion was made by Mrs. Stewart and seconded by Dr. Barberee to accept the COVID protocol updates as amended according to the guarantine protocols.

All members voted in favor of the motion. The motion carried.
