TEA REMARKS

Diana Sayavedra, TEA: Good evening Board President Tijerina, Superintendent Hinojosa, and the rest of the Board. It's a pleasure and an honor to be here with you this evening. Really, I have very brief remarks for you this evening. As you know yall will be engaging in a self-assessment in the Lone Star Governance Integrity Tool. And so, as I went back to look at the rubric and I looked at the progress that the Board is making there is some significant progress reflected as I see it from my perspective. Specifically, in the areas of progress and accountability, the systems, processes, advocacy and engagement and synergy and teamwork. So I know that the board has been working very hard over the course of the year to really meet the elements of the rubric so I applaud you and thank you for the work and the dedication to the community of South San Antonio ISD. I also know that the administrative team is working very hard to gear up for the new school year. Last board meeting we celebrated the work from the previous school year but the team has done a wonderful job. Your administrative academy will start next week. There is plans in the works for convocation, orientation for new teachers. Welcoming close to 120+ new employees to the school district. So, very exciting time to be in South San Antonio ISD. So again, I think that we are gearing up for a very successful 26-27 school year. Thank you so much.

SUPERINTENDENT'S REMARKS (NO ACTION / REPORT ONLY)

Dr. Saul Hinojosa, Superintendent of Schools: Thank you Mr. Tijerina. Boy it's been a busy summer to say the least. We've has so many things happening. It seems that kids were just crossing the stage and we are back for another year. Its an exciting time to be part of the district as we heard, over 120 new teachers. I mean it's, I can't stress the phenomenal job our HR department did and many of our curriculum staff in order to go out there and get high quality individuals. I know there was a period of time there we were short on bilingual teachers and we put a little carrot out there with a stipend/sign on bonus and we had more bilingual teachers. Actually, I had extra right to draw from. We are really excited, I think we are down to about 14 teachers. We had an ELT meeting this morning and there is like 7 at the high school. Only a few on the instructional or

curriculum side so we are much more prepared this year as far as having top tier certified teachers. Since we came in 11 of 13 campuses have new Principals. So again, a lot of change. When you look, even with all the change we saw some substantial improvement in the district and we will know on August 11th our rating but we do anticipate it will go up. I don't want to give a number because you know we still haven't received the files to decide where we land at right. But several campuses made substantial improvements, there were a few that regressed but over all we're excited about the trajectory. As far as our budget, it is ongoing. We do have a compensation plan but those are just some added positions this is not the official budget presentation. What I am gonna say is that we are probably one of the only districts to be in a situation where we can look at compensation of course I know the step raise is something's that's almost, we already factoring that in for next year. We are looking at additional possibilities for teachers. We're looking at performance pay for admin under the enhance TIA proposal. Our teachers are probably gonna get a biggest pay bump than any other district being that we put that money in savings for performance-based pay. So, our top tier teachers are gonna see maybe 5% if not more. So again its much more than many of the other districts so kudos to Mr. Osborne and his staff for putting us in the situation that we are in. We had to make some tough decisions. Of course, we cut 51 positions but that's due to the loss of enrollment but that's only gonna go back to our teachers in order to make sure that we compensate them accordingly. I do want to state that registration is open for new students. That opened up officially today. And as of today, we have 319 new students to the district. So, we are on track, you know, do the math we lost about 500 students, the seniors, so hopefully the input is gonna out pace the output which will you know as we budget we are budgeting about 200-300 less students than we have now. So if we get close to where we are now that's just gonna be a reward. Like icing on the cake for us. I do want to say that we did have a break in at Kazen MS where 5 AC units were taken over the weekend. If anyone in the community has any information regarding those units please contact South San police Department as we are investigating that matter. We are taking some extra precautionary measures in order to secure the remaining AC units that we have. I know the copper is the main thing that people are after. One of the things we will continue to push for is the VATRE which we know we want to add compensation to our paraprofessionals but most importantly is our facilities. We had several leaks you know over the last week or two probably about 6 buildings. Towards the end of the year we had to redirect some of our students due to the amount of water that was coming into some of our classrooms. So, we know that we need to do something and we hope that the community supports us in this VATRE in order to really start investing in our buildings. If we don't do anything they're going to continue to deteriorate as we know because of deferred maintenance but if we pass this then we don't have to use some of our general budget items towards these facilities. So that's the whole gist and I myself am gonna continue to reach out to community leaders to get this going. I do want to say that today the election for place 1, 4 and 6 is now open so anybody in the community who wants to apply to be an elected Trustee can do so. Of course, they do not take the dais until the commissioner makes that decision at any time. But we are having the election and that's for single member districts 1, 4, and 6. So anybody who does want to apply to be on the Board can do so. I do want to congratulate one of our Board of Managers who is not here, Mr. Jesus Rendon and his wife Judith. We now have a Jesus Rendon IV. So, congratulations go out to him and his family. I did talk to him today and he was very happy. I know he is with us in spirit. I do want to say we do have a new Technology Director comes from us from Aldine ISD, Mr. Armando Ontiveros, who's back there so welcome to South San ISD and I know you're gonna do a good job keeping the momentum in the district moving forward. Dr. Hinojosa invited him to say a few words about himself, which he did. Dr. Hinojosa continued: Last but not least tomorrow we will start our admin academy. This is where our administrative team will be in session. This is a learning opportunity for all of us. I know the Board received a book, Jim Collins, Good to Great, which is the theme this year. All of our admin was expected to read and basically focuses on 5 different parameters of how to go from good to great. We've made some advancements right but we are not done yet. And now that we know if we want to get to the next level, we know that there is still a lot of room for improvement it's about hiring the right people, you know being invested, being disciplined, focusing where all the things come together to eventually that the system is all working in one direction and going in an upward trajectory. So, we're on track, we're excited for the community so the next couple of days admin will not be on campus but they will be returning on Friday as we are back on a 5-day work week. The Board should have received an invitation to our Convocation which is going to be next week on Friday at 1pm. Should be a great way to launch the school year with over 1,000 employees at Tech Port. A big thank you goes out to Frost Bank who made a substantial donation for us to have the event there. This is the second year that they have provided the resources in order for us to have the event there. Again, we are excited to launch 2026 and really keep the district moving in a positive trajectory.
