# **Approval of Guaranteed Maximum Price for Additions and Renovations At Houston and Ginnings Elementary Schools**

June 26, 2012

#### **SUMMARY:**

This item requests approval of the Guaranteed Maximum Price submitted by Balfour Beatty for renovations at Houston and Ginnings elementary schools.

#### **BOARD GOAL:**

Vision ... In pursuit of excellence, the district will: remain committed to providing equitable and outstanding opportunities for every student on every campus

## PREVIOUS BOARD ACTION:

The Board discussed the plans for Middle School and various elementary renovations during the August 23, 2011, September 13, 2011, November 8, 2011 and December 13, 2011 meetings.

# BACKGROUND INFORMATION:

The 2007 Bond Authorization included funding for the additions and renovations at Houston and Ginnings elementary schools.

## **SIGNIFICANT ISSUES:**

The guaranteed maximum price (GMP) submitted by Balfour Beatty is \$4,934,263 for both campuses. In addition to the GMP the District will fund building permits, inspection fees and flooring in the amount of \$282,184.
