and \_\_\_\_\_ absent, constituting a quorum and among other proceedings had by said Board of Trustees were the following:

There came on to be heard the returns of the trustee general election held on the 1st day of May 2021, for the purpose of electing two members to the Board of Trustees, one for each of Places 6 and 7; and said returns of the trustee election having been duly canvassed by the Board of Trustees and there being cast at said election the following votes.

For Place 6, a total of 4,808 votes, with the candidates for said Place 6 receiving the following votes, to-wit:

Attached hereto and incorporated herein for all purposes as the tabulation required by Texas Election Code section 67.004 are the detailed voting center election results prepared by Dallas County Elections Department for the Coppell Independent School District May 1, 2021 Board of Trustees Election.

And it appearing to the Board of Trustees and the said Board so finding:

That Nichole Bentley received the highest number of votes cast in Place 6; and  
That Tracy Fisher received the highest number of votes cast in Place 7.

IT IS, THEREFORE, FOUND AND DECLARED AND SO ORDERED by the Board of Trustees of the COPPELL INDEPENDENT SCHOOL DISTRICT that the above trustee election was duly called, that notice of said election was duly posted and that said election was held in accordance with law; and that at said election Nichole Bentley was elected to said Board of Trustees in Place 6, subject to taking the oath of office; and Tracy Fisher was elected to said Board of Trustees in Place 7, subject to take the oath of office.

IT IS FURTHER FOUND AND DETERMINED that the date, place and subject of this meeting was duly posted on the bulletin board located in the Central Administration Office of this school district, a place convenient and readily accessible to the general public, and said notice, having been so posted, remained posted for at least 72 hours preceding the scheduled time of said meeting.
