Early Aug. 2015	Publish ten day notice of public hearing stating the purpose of the meeting is to discuss the proposed budget and proposed tax rate for the 2015-2016 fiscal year.	
August 2015	Public hearings on proposed 2015-2016 tax rate and proposed budget. A quorum must be present for public hearing on proposed tax rate. Final 2015-2016 budget approved at the regularly scheduled Board of Trustees meeting. Certified property values approved at regularly scheduled Board of Trustees meeting. Final 2015-2016 tax rate approved at the regularly scheduled Board of Trustees meeting.	
September 1, 2015	Approved 2015-2016 operating budget for General Operating, Food Service, and Debt Service funds implemented.
