My comments on the policies are included below. Regarding the breathalyzer form, I have questions as to whether this is used for every student and guest before a school activity? It's interesting because it certainly removes any 4th Amdt unreasonable search and seizure argument if the parent consents in advance to the test, but I can't imagine that we actually confirm that we have these on file before allowing a student to enter a dance? If we have figured out a way to administer that then great, but I caution having the form if we aren't using it consistently as it is contemplated because we then undermine our other ability to test without reasonable suspicion.

~~As far as the language,~~

~~I don't know what ADSS means, would staff ever administer a test?~~

~~I think I would delete "student" from school sponsored activity. That is too limiting and can create an argument that something was a District sponsored event, rather than a student event and therefore we didn't have consent to test.~~

~~-I would not list the type of activity but rather identify any and all District sponsored activity, whether it occurs on District premises or otherwise.~~

~~-I recommend revising this language: "I further understand that refusal to consent to this Brealyzer Parent consent form, a positive test, or a refusal to take the test, may result in disciplinary action up to and including dismissal from said school sponsored activity, from District Property, and further potential disciplinary action in accordance with District policies."~~

~~-I don't think that last sentence is necessary. It is our practice to call the parents with a positive test or refusal and that doesn't need to be something they consent to.~~
