Page(s) 5, 7, 8	The following guidelines are in effect on all KISD property and at any school sponsored or school related event including school buses, field trips, contests, etc.
Page 5	using inappropriate or demeaning language either verbal or written (including swear words, abbreviations, acronyms, or other terms as determined by the administration);
Page 7	inappropriate physical contact engaging in any form of sexual harassment (including inappropriate physical contact);
Page 8	harassment, name calling, verbal intimidation
Page 9	throwing objects that may cause bodily injury or damage property;
Page 24	<p>At the beginning of the student's sixth grade year, verification of the required administration of either the Hepatitis B immunization series, and documentation of either the varicella vaccine or Chicken Pox shall be required.</p> <p>Hepatitis B Three doses are required for the following grades in the following years: 2004-2005 K-10 2005-2006 K-11 2006-on K-12</p> <p>Varicella One dose on or after the first birthday for the following grades and years: 2004-2005 K-4, 6-10 2005-2006 K-11 2006-on K-12</p>

Page 29	<p>SCHOOL SAFETY TRANSFERS Each district receiving assistance under Title I, Part A of the Elementary and Secondary Education Act (20 U.S.C. 6301 et seq.) must allow a student to attend a safe public elementary or secondary school within the District, including a public charter school, if the student:</p> <ol style="list-style-type: none">1. Attends a persistently dangerous public elementary or secondary school, as defined by the state's education agency; or2. VISITORS TO CAMPUSES

All **visitors** to the schools, including anyone not specifically employed by the schools and assigned to the campus, are welcome to visit the campus; however, prominent notices shall be posted at each campus that all **visitors** must first report to the principal's office. Visits to individual classrooms during instructional time shall be permitted only with the principal's approval, and such visits shall not be permitted if their duration or frequency interferes with the delivery of instruction or disrupts the normal school environment. Campus visits for scheduled school events shall be exempt from this reporting procedure. (KISD Policy GKC local)
