Background Information:

- TASB recently released Update 127 with revisions to Legal policies to align with changes in law and policy, as well as proposed Local policy revisions to align with updates to Legal policies and other administrative updates.
- These policy updates were previewed at the July 23, 2026, Regular Meeting.

BJCF	Superintendent: Nonrenewal	Revisions align with language at DFBB (LOCAL) relating to accommodations of disability and the addition of two nonrenewal reasons related to SB 12 (89th)
CAA	Fiscal Management Goals and Objectives: Financial Ethics	Cross-reference updated to reflect changes to DH series of policies
DC	Employment Practices	Cross-reference updated to reflect changes to DH series of policies, and additional verbiage updated to reduce redundancies
DH	Employee Standards of Conduct	Cross-references updated to reflect changes to DH series of policies
DJ	Employee Recognition and Awards	Recommended for deletion to be more appropriately addressed in administrative regulations
DP	Personnel Positions	Recommended for deletion with restructuring of DP series of policies; portions moved to new code sections DPA (LOCAL) and DPB (LOCAL)
DPA	Personnel Positions: Principals	New code containing principal qualifications previously in DP (LOCAL); additional revisions made to align with TASB model job description
DPB	Personnel Positions: Other Personnel Positions	New code containing school counselor qualifications previously in DP (LOCAL); current DPB (LOCAL) content recommended for relocation to new DPC (LOCAL)

DPC	Personnel Positions: Substitute, Temporary, and Part-Time Positions	New code addressing substitute, temporary, or part-time positions relocated from DPB (LOCAL)
EHBB	Special Programs: Gifted and Talented Students	Recommended changes due to amendments to 19 TAC 89.1
FFF	Student Welfare: Student Safety	Definition of misconduct amended to include provisions from SB 571 (89th)
FOCA	Placement in a Disciplinary Alternative Education Setting: Disciplinary Alternative Education Program Operations	Recommended for deletion as HB 6 (89th) removed districts' authority to exempt itself from student discipline requirements through District of Innovation plan
