A Board Work Session of the Board of Trustees of Lewisville Independent School District was held on August 3, 2026, beginning at 6:00 PM in the LISD Admin Center's Boardroom, 1565-A W. Main St., Lewisville, TX 75067.

A. CALL TO ORDER AND ESTABLISH QUORUM

The meeting was called to order at 6:00 p.m. and a quorum established. The following Board members were in attendance: Ms. Allison Lassahn, Dr. Sheila Taylor, Ms. Katherine Sells, Ms. Jenny Proznik, Dr. Staci Barker, Ms. Madison Lopez, and Ms. Paige Dixon.

The Board observed a moment of silence in honor of Hebron High School graduate and U.S. Army soldier Isabella Gonzales. Remarks recognized her educational journey in Lewisville ISD, her service to the nation, and the lasting impact of her life on the district and community. The Board extended its condolences to her family and loved ones, and attendees honored her by wearing her favorite colors, black and purple. Dr. Taylor delivered a special prayer in honor of Isabella. Ms. Lassahn announced that a formal recognition honoring Isabella's service to the country will be held at the August 10, 2026 Regular Board Meeting and invited members of the community to attend in remembrance of her.

She reported that the annual Back to School Fair provided 4,000 backpacks to students, was supported by more than 250 volunteers and over 70 community partners, and served more than 3,500 registered students. Dr. Barker also shared that more than 700 students participated in district-wide summer learning programs, with additional students attending campus-based summer opportunities, reinforcing the district's commitment to continuous learning and student growth.
