On August 24, 2026 at 6:03 p.m., the Board of Trustees met in special session in the Board Room of the District Services Facility, 1100 Longhorn Drive, Weatherford, Texas, the meeting being open to the public.

The President certified that "The Provisions of Section 551.041 Sub Chapter C, Government Code as amended by the 73rd Legislature, have been complied with in connection with public notice of this meeting and a quorum is present."

The Pledge of Allegiance and the District Mission Statement were led by Ryann and Parker Woods.

The invocation was given by Adam Feriend.

Open Forum:

No one addressed the Board at this time.

New Business:

Adam Feriend moved to approve the final amendments for General Operating Amendment #11, Child Nutrition #3, and Interest & Sinking #1 as presented. Second by Dan Woods.

Voting yes: Catlin, Feriend, Ford, Lucia, Stephens, Woods. Absent: Wallace. Voting no: none. Motion passed.

Proposed 2026-2027 budget and tax rate information was presented. Brian Catlin, President, opened the public hearing at 6:12 p.m. With no one present to address the Board, the hearing was closed at 6:13 p.m.

After a motion by Adam Feriend and a second from Kindra Lucia, the Board voted to adopt the 2026-2027 Budgets for General Fund, Interest and Sinking, and Child Nutrition as presented.

Voting yes: Catlin, Feriend, Ford, Lucia, Stephens, Woods. Absent: Wallace. Voting no: none. Motion passed.

Adam Feriend moved to approve the No-New-Revenue Tax Rate, Voter-Approval Tax Rate, and Rate to Maintain Same Level of Maintenance and Operations Revenue and Pay Debt Service and approval of a proposed Interest and Sinking Rate for Debt Service that exceeds the minimum amount required. Second by Dan Woods.

During discussion, Sammy Stephens made a motion to postpone the motion regarding Item 6D until the September 14 Regular Board Meeting. Second by Kindra Lucia.

Voting yes: Catlin, Feriend, Ford, Lucia, Stephens, Woods. Absent: Wallace. Voting no: none. Motion passed.

Dan Woods made a motion to approve adopting an ordinance to set the tax rate for Maintenance and Operations and Interest and Sinking. Kindra Lucia seconded.
During discussion, Sammy Stephens made a motion to postpone the motion regarding Item 6E until the September 14 Regular Board Meeting. Second by Adam Feriend.
Voting yes: Catlin, Feriend, Ford, Lucia, Stephens, Woods. Absent: Wallace. Voting no: none. Motion passed.

There being no further business, the meeting adjourned at 6:18 p.m.
