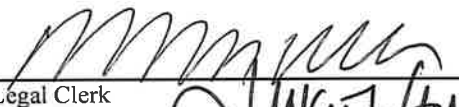

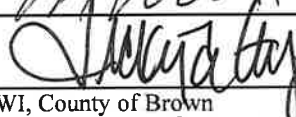

NOTICE OF PUBLIC HEARING ON HEALTH CARE PROVIDER PARTICIPATION PROGRAM (HCPPP) MANDATORY PAYMENT AMOUNTS FOR FISCAL YEAR 2027.

The Nueces County Hospital District (NCHD) Board of Managers will hold a public hearing on Tuesday, September 22, 2026, at 12:00 PM in the NCHD Board of Managers Meeting Room at 555 N. Carancahua Street (Tower II), Room 950-A, Corpus Christi, Texas, to receive comments on the proposed mandatory payment amounts under the HCPPP for Fiscal Year 2027 (10/01/2026 - 09/30/2027) (FY27) and on the intended use of the revenue collected during FY27. The Board is considering the amount of mandatory payments to be required from institutional health care providers within the District's boundaries (coterminous with Nueces County) during FY27. An institutional health care provider is defined as a hospital that provides inpatient services and is not owned or operated by the federal or state government. Representatives of affected providers and the public are invited to attend and comment either in-person or virtually.
