Approval of Minutes: Dunseth made a motion to approve the minutes from the PEF March 18, 2015 meeting seconded by Carter. All Yes.

Treasurer's Report: Jim Downs reported that the PEF regular checking account balance as of March 31, 2015 was 107,240.54 and further reported:

- 1. A \$250 check to David Kirkbride was written for his scholarship
- 2. Bills to pay:
 - a. \$381 for insert of newsletter in the Pana News
 - b. \$1,350 for newsletter printing to the Pana News
- 3. \$500 written to the high school for Evan Harbert for receiving the Carol Schramm Scholarship
- 4. \$500 check was received from Charles Kramer for the Ben & Loraine Kramer Scholarship recipient this year to be given to someone who will continue their education in college in the agriculture and/or technical disciplines.

New Business:

- 1. Becky, Jay and Dr. Lett listened to a webinar on an electronic donor board by Janis Displays Company.
 - a. Four sizes of boards were presented:
 - i. 46"/47" for \$11,995 with framing/mounting of \$975
 - ii. 52"/55" for \$14,995 with framing/mounting of \$1,235
 - iii. 60" for \$15,995 with framing/mounting of \$1,420
 - iv. 70" for \$16,995 with framing/mounting of \$1,890
 - b. Compare to:
 - 1. New wing for manual donor board with 90 name plates for \$2,247
 - 2. Normally would be \$3,000 but we still have 50 blank name plates.
 - 3. \$15.40/per plate to engrave.
 - 4. Usually takes 3 years to fill a donor wing.
 - 5. We're running out of room to put wings.
 - c. We will hope to make a decision by the PEF's May or June monthly meeting, but there is still a lot to be considered.
 - i. How will it be funded
 - ii. Dr. Lett to get hospital's feelings about their electronic donor board
 - iii. Include the hospital's access count if they have it.
 - iv. Dr. Lett to check out history of Janis Displays Company
 - 1. What about software updates
 - 2. Get a list of other Janis customers if possible.
- 2. Becky also recommended that we take Pana Pride off of our Labor Day Parade t-shirts so we are not confused with the Pride in Pana organization. No vote was taken but all agreed.
