Class Size Report

Superintendent Lutz reported on class size as recommended in SBR 400-30-1R: Class Size. Two out of 104 elementary classrooms exceed the guidelines. Four out of over 250 Bemidji High School courses exceed the guidelines by one or two students. No action was taken.
