Plan to Make Up Inclement Weather Days

Aubrey Independent School District was closed due to inclement weather on February 1-4 and again on February 9. Our plan for making up these five (5) days is as follows:

Plan for Students:

- > Students will attend school on previously scheduled snow days on Friday, April 22, 2011 and Friday May 27, 2011, making up for two (2) of the 5 days.
- At –risk and other targeted elementary and middle school students will attend mandatory tutoring after school each Wednesday and Thursday from 3:30 4:30 PM beginning Wednesday, February 16, 2011 and continuing until Thursday, April 21, 2011. This extra time will total 18 hours, making up the three (3) remaining days.
- At –risk and other targeted high school students will attend mandatory tutoring after school each Monday through Thursday from 7:45 8:15 and 3:45 4:15 beginning Monday, February 14, 2011 and continuing until Thursday, April 21, 2011. This extra time will total 18 hours, making up the three (3) remaining days.

Plan for Staff:

- > Teachers will attend school on previously scheduled snow days on Friday, April 22, 2011 and Friday May 27, 2011, making up for two (2) of the 5 days.
- ➤ Staff will extend their work hours to 7:30 4:30 each Monday through Thursday beginning Monday, March 7, 2011 and continuing until Thursday, May 26, 2011. The additional hours will total 22 hours, making up the three (3) remaining days.
