A Regular Board Meeting of the Board of Trustees of United I.S.D. was held on Wednesday, September 21, 2016 in the United ISD – Student Activity Complex, Fine Arts Building, 5208 Santa Claudia Lane, Laredo, TX 78043.

- I. An announcement was made by the Board President, calling the meeting of the United Independent School District to order at 6:02 p.m. The record showed that a quorum of Board members was present, that the meeting had been duly called, and that notice of the meeting had been posted in accordance with the Texas Open Meeting Act, Texas Government Code Chapter 551.
- II. Board Announcements
- III. Public Comments: Comments are limited to three minutes per speaker. The Board Parliamentarian will be the timekeeper and will inform the speaker when they have one (1) remaining minute. No more than three (3) persons will be allowed to speak on any side of an issue. Should there be more than three (3) people who wish to speak on a particular issue they need to select not more than three (3) representatives to speak for them. Comments must address items listed on the agenda. The presiding officer or designee shall determine whether a person who wishes to address the Board has attempted to solve a matter administratively. If not, the person shall be directed to the appropriate policy, as noted in BED (LOCAL), to seek resolution before bringing the matter to the Board at a subsequent meeting. Pursuant to 551.042 of the Texas Government Code, no Board Member or Administrator may respond to a member of the public, unless such response is a recitation of District policy or a statement of specific factual information. When a speaker comes to the podium, please indicate what agenda item you will be addressing. Furthermore, please refrain from mentioning any employee's name and any complaint about any employee's duties or responsibilities should be channeled through the appropriate grievance policy. Additionally, pursuant to board policies BED (LEGAL) and BED (LOCAL), drifting from the stated topic or becoming disruptive shall result in a warning from the board president. A

second violation will result in forfeiture of your allotted time and removal from the board meeting. Disruptions include speaking on behalf of or against a person running for political office, promotion of a for-profit organization, or advertisement of products or services to the Board.

Dr. Dolores Medrano thanked the board for the opportunity to speak and stated that last month she had voiced her concern regarding 12 promotions that were given in the face of the 30 million dollar deficit and the fact that 20% of the campus budget was cut. She expressed her concern with another promotion for central office Planner given the crisis the district is facing.

She stated there was something very strange about this position in that at last week's meeting they were told that this position was filled September 1, however in the campus directory this person was already identified in the new position and this directory was approved in June.

Dr. Medrano stated she had several concerns: One is that there were no questions asked by the board regarding if this position was really needed right now. Second, there is no question as to how much this is going to cost us. She stated that when she is in a financial crisis, she starts looking for ways to cut the budget and not just approve everything that is there. She also stated that, to her, there is no control over administration by the board in terms of spending and the ones that are suffering are the campuses.

Dr. Medrano stated her other concern was relating to the discretionary funds that were presented at last week's committee meeting. She commented that out of seven previous superintendents, not a single one ever had discretionary funds given to board members and out of 27 superintendents that she has worked directly with, not one ever gave board members discretionary funds and the reason why is because it is not the job of the board members to be directly managing the campus operations. She expressed her concern that whenever the board starts meddling and giving out favors to campus principals then they will feel that they have the right to tell them who to hire, how to discipline, how to do so many things which she has already heard is happening. Dr. Medrano again expressed her concern that when the district is suffering and all these monies are being cut from the campuses, their discretionary funds should have been pulled into one account and divided among all the campuses to help the principals with the shortfall that they are facing.

Rebecca Leza introduced herself to the board members and stated she attends Our Lady of Guadalupe School and hopes to one day serve the community like they do. She thanked the board for working with the schools and promoting educational endeavors throughout the community.

Isabella Hernandez introduced herself to the board members and stated she attends Our Lady of Guadalupe School. She thanked the board members for all the work they do for the community and for all the youth in our city. Isabella concluded by stating "let us join forces in educating the children of Laredo."

Herlinda Martinez introduced herself and stated she is the principal of Our Lady of Guadalupe School. She commented that on behalf of the students, parents, staff she thanked them for everything that they do for the community especially for making it possible for them to upgrade some of their classrooms by gifting some of the excess furniture that they have in the district. She commented that the school is a non-profit organization but they have the same vested interest that UISD has which is educating and promoting literacy throughout our community. She said she hopes they continue joining forces and keep working together to form the leaders of tomorrow.

Sr. Vuong M Do addressed the board and stated she was from Mary Help of Christians School. She thanked the board for their generosity and their kindness for thinking of their school. She stated that they are also a private organization and that the items given to their school will make a difference to the children that they

serve. She also stated that the future is in our children and we provide them with the education they need so that Laredo can be a strong future and so the children can one day be part of helping build society.

Mr. Juan Roberto Ramirez requested to refer back to Board Announcements and asked for a moment of silence for a transportation employee who passed away recently.
