110 - DULUTH PUBLIC SCHOOLS WEBSITE ACCESSIBILITY POLICY

I. PURPOSE OF POLICY

In order to comply with Section 504 of the Rehabilitation Act of 1973 and Title II of the Americans with Disabilities Act of 1990, websites must meet the Web Content Accessibility Guidelines (WCAG) as instituted by the World Wide Web Consortium (W3C). Those schools not complying are subject to official complaints from the U.S. Department of Education Office for Civil Rights, fines from the U.S. Department of Justice, and further legal action.

As part of the WCAG 2.0 specification to make school websites accessible and ADA compliant, Duluth Public Schools is required to make public its Web Accessibility Policy.

II. GENERAL STATEMENT OF POLICY

The Duluth Public Schools is committed to ensuring accessibility of its website for students, *parents families, caregivers*, and members of the community with disabilities. All pages on the Duluth Public Schools website will conform to the W3C Web Accessibility Initiative's (WAI) Web Content Accessibility Guidelines (WCAG) 2.0, Level AA conformance, or updated equivalents of these guidelines.

The Superintendent, <u>/School Director or designee</u>, is directed to establish procedures whereby students, <u>parents families, caregivers</u>, and members of the public may present a complaint regarding a violation of the Americans with Disabilities Act (ADA), Section 504 and Title II related to the accessibility of any official District web presence which is developed by, maintained by, or offered through the District or third party vendors and open sources.

III. WEBSITE ACCESSIBILITY

With regard to the Duluth Public Schools website and any official Duluth Public Schools web presence which is developed by, maintained by, or offered through third party vendors and open sources, the Duluth Public Schools is committed to compliance with the provisions of the Americans with Disabilities Act (ADA), Section 504 and Title II so that students, *parents families, caregivers* and members of the public with disabilities are able to independently acquire the same information, engage in the same interactions, and enjoy the same benefits and services within the same timeframe as those without disabilities, with substantially equivalent ease of use; and that they are not excluded from participation in, denied the benefits of, or otherwise subjected to discrimination in any Duluth Public Schools programs, services, and activities delivered online.

All existing web content produced by the Duluth Public Schools, and new, updated and existing web content provided by third-party developers, will conform to Web Content Accessibility Guidelines (WCAG) 2.0, Level AA conformance, or updated equivalents, by **October 31, 2018** [Date]. This Regulation applies to all new, updated, and existing web pages, as well as all web content produced or updated by the Duluth Public Schools or provided by third-party developers.

IV. WEBSITE ACCESSIBILITY CONCERNS, COMPLAINTS AND GRIEVANCES

A student, parent, <u>caregiver</u> or member of the public who wishes to submit a complaint or grievance regarding a violation of the Americans with Disabilities Act (ADA), Section 504 or Title II related to the accessibility of any official Duluth Public Schools web presence that is developed by, maintained by, or offered through the Duluth Public Schools, third party vendors and/or open sources may <u>contact the Superintendent's Office by calling 218-336-8752 or by completing the online Website Accessibility Complaint/Request Form. The Superintendent, or designee, shall immediately investigate the complaint or grievance. <u>complain directly to a school administrator, or the school or District webmaster. The initial complaint or grievance should be made using Website Accessibility Complaint/Request Form, however, a verbal complaint or grievance may be made. When a school administrator or School/District webmaster receives the information, they shall immediately inform the fwebsite compliance coordinator].</u></u>

Whether or not a formal complaint or grievance is made, once the Duluth Public Schools has been notified of inaccessible content, <u>that content will be</u> <u>immediately made available in an accessible format to the reporting party.</u> <u>effective communication shall be provided as soon as possible to the</u> <u>reporting party to provide access to the information. The Complainant</u> <u>should not have to wait for the investigation of the complaint to be</u> <u>concluded before receiving the information that he/she was unsuccessful in</u> <u>accessing.</u>

Complaints should be submitted in writing, via email, <u>or</u> by completing the <u>website</u> complaint form <u>or by calling the Superintendent's Office at 218-336-8752.</u> To <u>file a complaint or grievance regarding the inaccessibility of the Duluth</u> <u>Public Schools public website content, the Complainant should submit the</u> <u>website feedback form.</u>

The formal ADA non-compliance complaint should include the following:

- Name
- Address
- Date of the Complaint
- Description of the problem encountered
- Web address or location of the problem page
- Solution desired
- Contact information in case more details are needed (email and phone number)

The <u>ADA non-compliance</u> complaint or grievance will be investigated by the <u>Superintendent's Office [website compliance coordinator]</u> or another person designated by the Superintendent <u>/School Director</u>. The student, parent, <u>caregiver</u>, or member of the public shall be contacted no later than five (5) working days following the date the <u>website accessibility compliance coordinator</u> <u>Superintendent's Office</u> receives the information. The procedures to be followed are:

 An investigation of the complaint shall be completed within fifteen (15) working days. Extension of the timeline may only be approved by the Superintendent-<u>/School Director</u>.

- The investigator shall prepare a written report of the findings and conclusions within five (5) working days of the completion of the investigation.
- The *investigator Superintendent or designee* shall contact the Complainant upon conclusion of the investigation to discuss the findings and conclusions and actions to be taken as a result of the investigation.
- A record of each <u>ADA non-compliance</u> complaint and grievance made pursuant to <u>Governing Board</u> Policy <u>[###]</u> <u>110</u> shall be maintained at the Duluth Public Schools <u>Superintendent's</u> office. The record shall include a copy of the complaint or grievance filed, report of findings from the investigation, and the disposition of the matter.
