

RESOLUTION CALLING FOR TRUSTEE ELECTION

WHEREAS, in accordance with Section 33-503 Idaho Code, the Board of Trustees shall cause to be conducted its Annual Trustee Election on the 3rd Tuesday in May (May 16th 2017) for the purpose of electing Trustees for Zone #1 and Zone #4.

NOW, THEREFORE, be it resolved by the Board of Trustees of Joint School District No. 331, Minidoka, Cassia, Jerome, and Lincoln Counties, Idaho, as follows:

Section 1. That on said date the polls shall be opened between the hours of 8:00 a.m. and 8:00 p.m.

Section 2. That said election shall be held as specified in the **Notice of Trustee Election**, attached herein.

NOTICE OF DEADLINE FOR FILING DECLARATION OF CANDIDACY TRUSTEE ELECTION JOINT SCHOOL DISTRICT NO. 331 MINIDOKA, CASSIA, JEROME, AND LINCOLN COUNTIES

NOTICE IS HEREBY GIVEN: That an election shall be held on Tuesday, **May 16th, 2017**, and the polls of said election will be open between the hours of **8:00 a.m. and 8:00 p.m.**, within said district for the purpose of electing a **School Board Trustee for Zone #1** and a **School Board Trustee for Zone #4**, pursuant to Idaho law.

Any person legally qualified to hold the office of School Trustee for Minidoka County Joint School District No. 331, for Trustee in **Zone #1** or **Zone #4** may file a Declaration of Candidacy for that office.

Declaration of Candidacy forms are available at the School District Office. Declarations of Candidacy meeting all legal requirements shall be filed with the School District Board Clerk located at the School District Office, 310 10th St,

Section 4. That no person shall vote at such Trustee election that is not at the time of election:

1. A United States Citizen, a **Qualified Elector** of the district and a qualified elector of the trustee zone, for at least 30 days preceding the day of election, and 18 years of age or older, within the meaning of Article 6, Section 2 of the Idaho Constitution; and Chapter 4, Title 33, Idaho Code, and
2. A bona fide resident thereof.

Section 5. That no person shall be permitted to vote at said election without Photo Identification.

Section 6. That voting at said election shall be by secret and separate ballot, and each ballot shall be prepared by the County.

Section 7. That immediately following the close of the polls, the County Clerk shall compute the results of the election, making the count in public view, and shall immediately, within not more than ten days thereafter, certify the election to the Clerk of the Home County. The certified election results, of electing counties, will then be delivered to the Board Clerk of Minidoka County Schools. The Board of Trustees shall thereupon **canvass** such returns at a meeting to be held for that purpose at the regular meeting place of the Board, next appointed time, and the person receiving the greatest number of votes cast within the Zone shall be declared by the Board of Trustees to be the Trustee from that Zone.

Section 8. That the County Clerk shall publish the **Notice of Deadline for Filing Declarations of**

Candidacy and Notice of Election.
