# **High School Course Catalog and Planning Guide**

### **Board Goals**

The High School Course Catalog and Planning Guide for the 2012-2013 school year supports the following Board goals: Vision goal I C - remain committed to providing equitable and outstanding opportunities for every student on every campus; Teaching & Learning goal II A – cultivate a consistent, strong, district-wide balanced curriculum based on ongoing needs assessment that supports all students; and Climate goal III D – instill in students a love of lifelong learning.

# Purpose of Report

The course catalog is comprised of all of the high school course offerings, graduation requirements, testing information, GPA guidelines and information, and college information, and also serves as a planning guide. The changes made to this new catalog were for purposes of updating the new STAAR state assessment requirements, deleting courses no longer offered, adding new courses already approved by the Board, reflecting any Board approved changes, and for text editing. As a direct result of suggestions made by the Board, a personal graduation planner was developed and is now a permanent part of the planning guide as well as additional information about scholarships for attending college. All required or editing changes proposed are the direct result of a review by all high school principals, associate principals, counselors, registrars, the Academic Leadership Team, the ATC principal, content area Curriculum Coordinators, the Director of Counseling, the Director of Fine Arts, the Director of Bilingual/ESL Education, the Director of Athletics, the Director of Special Education, and the Director of Secondary Curriculum, Instruction, and Staff Development.
