The fiscal year of the school district is July 1 – June 30. Within or before the end of the first quarter of each fiscal year (September 30), a School Board must adopt an annual budget that it deems necessary to defray all necessary expenses and liabilities of the district, and must specify the objects and purposes of each item and amount needed for each object or purpose. Such budget should be prepared in tentative form and made available for public inspection. The notice of the public hearing and public inspection was posted in the Kane County Chronicle on August 18, 2022.
