

**RESOLUTION AUTHORIZING REDUCTION OF  
CERTAIN FUND LEVIES FOR THE 2022 LEVY YEAR**

WHEREAS, on December 19, 2022, the Board of Education of School District Number 90, Cook County, Illinois ("School District") did adopt a certificate of tax levy for the 2022 levy year and subsequently filed the same with the County Clerk of Cook County ("County Clerk"), and

WHEREAS, the County Clerk has notified each Cook County taxing district, which is now subject to the Property Tax Extension Limitation Act ("PTELA") that it may direct the County Clerk's Office, by proper resolution, to make specific and necessary reductions to its tax levy for the 2022 levy year to met the requirements of the PTELA.

NOW THEREFORE, BE IT RESOLVED by the Board of Education of School District Number 90, Cook County, Illinois as follows:

Section 1. That the Board of Education hereby finds that all of the recitals contained in the preambles to this Resolution are full, true and correct and does hereby incorporate them into this Resolution by reference.

Section 2. That the Board of Education hereby authorizes and directs the County Clerk to make the necessary reductions to the School District's tax levy for the 2022 levy year in order that the levies by fund shall be no less than the following amounts as indicated:

Education	\$19,160,000
Operations & Maintenance	2,060,000
Transportation	1,030,000
Municipal Retirement	329,600
Social Security	329,600
Special Education	1,545,000
Working Cash	103,000
Fire Prevention & Safety	257,500

Section 3. That the Board of Education further authorizes and directs the County Clerk that if any additional reductions are required to be made to the School District's tax levy beyond those projected and specified by the Board of Education in Section 2 above, that such reductions shall be made to the following funds as indicated:

Education	100%
Operations & Maintenance	0%
Transportation	0%
Working Cash	0%
Municipal Retirement	0%
Social Security	0%
Special Education	0%
Fire Prevention & Safety	0%

Section 4. That the Superintendent of Schools of this School District be and is hereby directed to file a certified copy of this Resolution with the County Clerk as soon as possible following its adoption and execution.

Section 5. That all other resolutions or parts of resolutions in conflict herewith be and the same are hereby repealed and this Resolution shall be in full force and effect immediately and forthwith upon its passage.
