TOPIC: Approval of Bids for the Aquila Elementary School Addition and Remodel - Bid Package 2 BACKGROUND INFORMATION

On October 18, 2024, bid packages were posted for the construction services for Saint Louis Park Aquila Elementary School Addition and Remodel – Bid Package 2. The 19 Trade Packages were to be competitive bid.

On November 14, 2024, all the Trade Packages were opened and tabulated with no alternates for a total value of \$11,562,840.00.

The subtotal with alternates of the 19 competitive trade packages is \$11,562,840. This bid amount is in keeping with the budget for this portion of the project.

The remaining costs are for the Construction Manager Agent (CMa) General Conditions \$1,657,973.

The total estimated cost of SLP Aquila Elementary School Addition and Remodel – Bid Package 2 is \$13,220,813 (not accounting for contingencies, fees, insurances, FF&E, etc...)

## Recommendation

It is recommended that the School Board of Independent School District #283 approve the above bids in the amount of \$11,562,840, and Knutson General Conditions of \$1,657,973, for a total of \$13,220,813.

## Resolution

BE IT RESOLVED that the School Board of Independent School District #283 does hereby award 19 competitive bid packages in the amount of \$11,562,840.

BE IT FURTHER RESOLVED that the School Board of Independent School District #283 does hereby approve the Knutson General Conditions for the sum of \$1,657,973 for a total cost of \$13,220,813.
