This is what I am referring to when I say class_id. Every class subject (ex: English II, AP US History, Geometry, Grade 6 Math) is given a string of numbers which is standard across the state. This is the service_id, but you could also just provide the name you call the class (I figured the service_id would be easier because that is the format you already send data to the state in). The type of class (ex: pre-AP geometry vs regular on level geometry) is not reported to the state, but is often tracked by the
