### I. SUPERINTENDENT'S REPORT

A. VCS Robotics Teams - Eric Hackman

- B. Student Enrollment Count Day February 13, 2019
  Supt. O'Neill reminded staff about count day. No major changes from the fall count are expected.
- C. Legislative Report

Between 1995 and 2015, survey results showed Michigan ranked 50<sup>th</sup> in the country for school funding growth. On a positive note, school aid is projected to grow steadily this year and next.

  - 1. Budget Progress Report for the Month Ending January 31, 2019: Asst. Supt. Goss presented the budget progress report for January 2019, showing total revenues of \$10,673,120; total expenditures of \$12,419,409 and deficiency of revenues over expenditures of \$(1,746,289).

### 2. Bond Update

Asst. Supt. Goss updated the board on a technology contract included with the packet. The contract is to be funded with the 2014 bond funds. These are replacements for older systems.

B. Shifting the Culture - Matt VanDussen

Principal VanDussen presented the Vicksburg Middle School Annual Report. He expressed appreciation to the board for building improvements including the new windows and doors installed this year. He shared MSTEP and student growth data. Tutorial has been in place for over a year now and has had a large impact on students. He reported restorative justice has made a big difference in the school with students being able to talk and resolve their problems together. The MS operates as a Professional Learning Community ensuring all student learn.
