Transfer students can apply through the end of the first nine weeks of 6th grade due to the compacted curriculum. Exemptions include when students have come from another district that offers a compacted curriculum or if a student wishes to transfer from one academy to another. The deadline for this is the end of the first semester of 6th grade so that the student is not too far behind in the Academy Electives and requires approval from Academy coordinator and Principal.
