The Illinois School Code requires that school districts in Illinois post Administrator and Teacher salary and benefit information on the school district website by October 1 of each school year. The report must also be presented to the Board of Education and submitted to the Regional Office of Education.

The attached Administrator and Teacher Salary and Benefits Report contains 2016/2017 salary and benefit information and includes the categories listed below:

# **Administrator and Teacher Salary and Benefits Report**

## **Public Act 096-0266**

The Illinois School Code requires that school districts in Illinois post Administrator and Teacher salary and benefit information on the school district website.

The Administrator and Teacher Salary and Benefits Report lists 2016/2017 salary and benefit information in the following categories:

**Name** – Last Name, First Name and Middle Initial

**Position** – *See below, as required to post by the Illinois School Code*

**Base Salary** – The contracted dollar amount the employee is paid in the 2016/2017 school year for the time worked for the school year for this position. Stipends and extra duty pay are not included in base salary. Base salary also includes any retirement enhancement amount in the final years of service. A separate line item will be noted for base salary for summer school.

**FTE** – The full-time equivalency (FTE) for each administrator and teacher in the District.

**Vacation Days** – The number of vacation days allocated to each administrator in the District.

**Sick Days** – The number of sick days allocated to each administrator and teacher in the District.

**Bonuses** – Any compensation in the form of bonuses.

**Annuities** – Any compensation in the form of annuities.

**Retirement Benefits** – The annual dollar amount of the required TRS member contribution paid by the District.

**Other Benefits** – The annual dollar value of health insurance, dental insurance, and life insurance paid by the Board for each administrator and teacher in the District.
