7. What is the mission of the non-profit/community organization?

Our mission is to build positive relationships between youth and police through recreation and positive interaction with youth from the City of Little Rock and police officers. To promote (among camp participants) positive self-esteem, build leadership skills, garner tolerance for diversity, and increase the ability to make sound choices in difficult situations.

8. What service(s) does the non-profit/community organization provide?

This camp provides the youth of our community the opportunity to see and experience a wide range of activities they may not normally experience (i.e. canoeing, fishing, wall climbing). The majority of these activities take place outdoors in a campsite setting. We also emphasize cultural diversity, by discussing the how we are more alike than not, based upon our racial and social economic backgrounds.

 Please describe the volunteer activities students will participate in at the nonprofit/community organization and how those activities may connect to curriculum learning goals.

For four days and three nights, volunteers would be responsible for assisting Police Officers with mentoring and supervising the campers. Volunteers would encourage camper participation by establishing rapport with the campers along with physically

- participating in camp activities. Lastly, volunteers assist with bridging the communication gap between the adults and the camp participants.
- 10. What are the non-profit/community organization procedures and policies to ensure the safety of student volunteers?

All volunteers are assigned to group of Police Officers and report directly to the Police Supervisors. At no time are the volunteers left alone or alone with a camper. The volunteers are not allowed to leave the site and they are not allowed to have any form of contraband on the site. These volunteers are given written documents of rules and expectations for duration of the camp.

11. List any special considerations of the non-profit/community organization.

The majority of these volunteers have participated in the camp when they were of age. This makes our volunteers extra special in being able to relate to our campers who may be shy or not accustomed an outdoor setting. The volunteers' participation in our camp is invaluable, making them a vital part to the success of our camp each year.
