

**SODA SPRINGS JT SCHOOL DISTRICT #150
CARIBOU, BEAR LAKE, BONNEVILLE COUNTIES, IDAHO**

**RESOLUTION CALLING FOR
SUPPLEMENTAL LEVY ELECTION**

WHEREAS, the Board of Trustees (the “Board”) of the Soda Springs Jt. School District #150 Caribou, Bear Lake, Bonneville Counties, Idaho (the “District”), has heretofore, by resolution duly adopted, created and established a Supplemental Tax Levy;

WHEREAS, in accordance with Section 33-802(3), Idaho Code, as amended, the Board of Trustees of the Soda Springs Jt. School District #150 Caribou, Bear Lake, Bonneville Counties, Idaho, has determined there is a need for a supplemental levy in the amount of _____ dollars (\$), for one (1) year for the purpose of paying all lawful expenses of maintaining and operating the District for the fiscal year beginning July 1, 2015 and ending June 30, 2016.

NOW, THEREFORE, be it resolved by the Board of Trustees of Soda Springs Jt. School District #150 Caribou, Bear Lake, Bonneville Counties, Idaho, as follows:

- Section 1. That a supplemental levy election be held, and the same is hereby called to be held in the Soda Springs Jt. School District #150 Caribou, Bear Lake, Bonneville Counties, Idaho on March 10, 2015, for the purpose of submitting to the qualified electors of the District, the question set out in the form of the ballot appearing in Section 5 hereof.
- Section 2. That on Tuesday, March 10, 2015, said election shall be opened between the hours of 8 a.m. and 8 p.m., as set by the Clerk of Caribou County, Idaho (the “County Clerk”).
- Section 3. That said election shall be held as specified in the Notice of Election, set out in Section 6 herein.
- Section 4. That said election shall be conducted as other school elections by the County Clerk in accordance with Title 34, Idaho Code.
- Section 5. That voting at said election shall be by secret and separate ballot, and each ballot shall be prepared by the County Clerk in substantially the following form:
