**OPENING OF MEETING**

**Call to Order and Signing of Visitors' Register**

Mrs. Zibrat called the meeting to order at 8:01 AM and invited members of the audience to sign the visitors' register.

**1. STUDY**

**A. Governing Board Retreat**

Mr. Bejarano provided an overview to the Board about the upcoming AdvancED accreditation visit. His overview included the Board's role in that process, and the value of the Accreditation quality-assurance method to the District.

Discussion ensued related to a number of issues affecting the District through FY 2018.

Mr. Nelson provided an update about the ongoing Bond (funded) projects. Detail was provided about some current construction-related issues at Amphitheater High School. Updates about on-going projects at Donaldson, Mesa Verde, and Wetmore were given. Plans for a new elementary school were reviewed; some discussion ensued.

Mr. Nelson reviewed the implementation of the new Arizona College and Career Readiness Standards (AZCCRS).

Mr. Nelson reviewed the current budget situation at the State legislature. A “hold harmless” proposal for school districts for the upcoming year was discussed; he explained the rationale for this action as related to curriculum and new assessment needs. Additional discussions ensued concerning the State budget picture and possible affects on education funding, including potential reductions for FY 2013-2014 and FY 2014-2015 as associated with the national-level Sequestration (austerity) program.
