1. Opening of Meeting

- All hands were sworn.
- Vice President Ware-DeVaull read the letter written by administration.
- The student provided details on the incident.
- The administrators gave their account of the incident.
- The Trustees asked the student and guardian questions and they were answered by the student and guardian.
- The guardian spoke on the student's behalf.
- The attorney spoke on the student's behalf.
- Vice President Ware-DeVaull asked the guardian, uncle, attorney, student and administrators to step out for deliberations.
- After deliberations, the guardian, uncle, attorney, student and administrators were asked back in.

- Vice President Ware-DeVaull read the recommendation: student 15-2024-25 not to return to SPS for the remainder of the 2024-2025 school year. Student 15-2024-25 will return at the start of the 2025-2026 school year. The administrators will arrange for the student 15-2024-25 to take their finals.
- Trustee Johnson moved and Trustee Denson supported the recommendation.

Vice President Ware-DeVaull called for the vote.

Absent: Trustee Smith-Thomas, Trustee Bland

Trustee Holloway voted yes with exception: Trustee Holloway states it should be time served and return to school but the time to get another vote at the next board meeting the school year would be over.

Trustee Belk states that because of the perception and climate of our culture student 15-2024-25 should not return to SPS.
