

## **Service Agreement**

### **GALVESTON INDEPENDENT SCHOOL DISTRICT (GISD) AND TEEN HEALTH CENTER**

This service agreement was entered into on 29<sup>th</sup> day of August, 2023, by and between the Galveston Independent School District ("GISD") and the Teen Health Center ("Center").

#### **BACKGROUND:**

**Whereas**, GISD recognizes the importance of providing comprehensive mental health services to its High School (Ball and AIM Campuses) and Disciplinary Alternative Education Program (DAEP) students; and

**Whereas**, the Teen Health Center is an established entity with expertise in counseling services;

Now, therefore, in consideration of the mutual covenants contained herein, GISD and the Teen Health Center agree as follows:

#### **TERMS OF AGREEMENT:**

##### **Scope of Services:**

- The Teen Health Center agrees to provide counseling services to AIM, GISD Ball High School and DAEP students.
- Counseling services may include individual counseling, group therapy, crisis intervention, and other related mental health services.

##### **Funding:**

- GISD will provide \$90,000 to the Teen Health Center using Moody Foundation funds to employ a Mental Health Therapist.
- Payment will be made in bi-annual installments, with the first payment to be made at the end of the Fall Semester for an amount not to exceed \$45,000.

##### **Duration:**

- This service agreement shall be effective during the 23-24 school year and shall continue until June 30<sup>th</sup> 2024.
- Either party may terminate this agreement with 30 days' written notice.

##### **Reporting and Evaluation:**

- The Teen Health Center shall provide GISD with quarterly reports detailing the necessary information needed to comply with the Generation Moody Foundation requests.
- GISD may, at its discretion, conduct evaluations of the counseling services to ensure they align with the needs of the students.



**Confidentiality:**

- Both parties agree to maintain the confidentiality of student information in accordance with applicable laws and regulations.

**Communication:**

- Regular communication between GISD and the Teen Health Center will be facilitated to address any concerns, modifications, or updates to the agreement.

**Legal Compliance:**

- Both parties shall comply with all applicable federal, state, and local laws and regulations governing the provision of counseling services to students.

**Right to terminate:**

- This Agreement may be terminated by either Party with or without cause by providing the other Party thirty (30) calendar days' written notice of intent to terminate. Any termination of this Agreement as permitted by this paragraph shall not relieve any Party from payment of any fees accruing prior to the effective date of termination or from completing obligations in progress prior to the effective date of such termination.


