Food Manager Certification

The food manager certification is obtained by passing a Department of State Health Services (DSHS) approved certified food manager certification examination. This certification is valid for five years.

County health departments, public health districts, and city health departments must accept certificates issued for passing any DSHS approved examination as meeting the training and testing requirements of the Texas Health and Safety Code, Chapter 438.

The Certified Food Manager Training Programs offer 8-14 hour training sessions to managers who are new or experienced to the food industry and have need of quality training. A DSHS approved on-line examination is given in English and Spanish at the completion of the training. Upon successful completion of the exam, a Certified Food Managers Certificate is issued that is valid in Texas.

Eagle Pass Independent School District Cafeteria Managers obtained this Certification to meet health operation guidelines and maintain a higher level of sanitation for the safety of our students.
